Hi Alex, We would like to to understand how to calculate the total of the bid bond. The RFP is currently listed as a 5-year contract, will it be a 5-year lumpsum amount or 1 year's contract value? Thank you.	The bid bond would be structured as 5% of the total lump sum 5-year contract amount.	BID GUARANTEE
Item # 11 cleaning appliances is this including the inside of microwaves and Refrigerators in the kitchenettes area?	Cleaning appliances does include the inside of said appliances (microwaves, refrigerators, etc.) in the kitchenettes.	PERFORMANCE REQUIREMENTS
Bid bonds/ performance bonds usually take 30 days to obtain and require business and personal financials depending on the size of the project. Can this be waived?	The bid bond requirement is unable to be waived.	BID GUARANTEE
Is there a daily task list for all buildings?	There is not a task list per building, however a list of items / areas expected to be cleaned is located in the following RFP section: 5. STATEMENT OF WORK. H. Janitorial Work- Performance Requirements	STATEMENT OF WORK
What is the schedule for the janitorial services for each building, do all buildings get cleaned 5 days a week? Are there some that are cleaned less or more days?	The NWSA Admin (Seattle) and Blair Gate Guard House would be less than 5 days (3 per week). All other facilities would be 5 days per week.	OFFER SHEET
Do all employees need to apply for their TWIC card? Or go through the federal background check?	The awarded Contractor shall have a minimum of one TWIC compliant employee trained as an escort for every five workers not possessing TWIC cards working on a secured or restricted site. The Contractor shall have a criminal background check for each employee working on the contract. Evidence of the background check(s) shall be on file with the Contractor for each employee. Can the State Business License be provided upon award of contract?	Per Section 4. LICENSING and FEES of the RFP. You must have a State of Washington business license (a State “Unified Business Identifier” known as UBI #) prior to signing the contract. It will be part of the responsibility check prior to contract execution but is not required for the initial proposal.	LICENSING and FEES
I would like to verify that the Sqft for the NWSA Admin Building is 1,077 sqft. If I recall correctly it is listed as a 3 story building.	The NWSA only occupies the 3rd floor. The 1,077 sqft represents that floor.	EXHIBIT 8
